**Booths:** All booths are required to be staffed from 11:00am – 11:00pm daily. A limited number of “Static” booths are available upon request. Inside booths include 8’ back drape and 3’ side drape. All booths include an electrical outlet, **(1) Exhibitor Parking Pass and a limited number of admission passes for workers per vendor.** Additional worker admission is available at a discounted rate. We do not provide chairs or tables.

**Parking:** \$7 single entry parking; \$30 general parking allows for unlimited returns each day wherever traffic is being directed; \$35 exhibitor parking allows parking near main gate and drive-in deliveries prior to 10:30am each day.

**Attendance:** Average attendance at the Douglas County Fair is 65,000+
